THE REVOCATION OF REGIONAL REGULATION NUMBER 15 OF 2020  
CONCERNING THE ADAPTATION OF NEW HABITS IN THE HANDLING OF  
THE CORONA VIRUS DISEASE 2019 (COVID-19) OUTBREAK

BY THE GRACE OF GOD ALMIGHTY

THE MAYOR OF BEKASI,

- Considering:
- : a. that in order to handle the Corona Virus Disease 2019 (COVID-19) outbreak, Bekasi City Regional Regulation Number 15 of 2020 concerning the Adaptation of New Habits in Handling the Corona Virus Disease 2019 (COVID-19) Outbreak was enacted, as amended by Bekasi City Regional Regulation Number 9 of 2022 concerning Amendments to Regional Regulation Number 15 of 2020 concerning the Adaptation of New Habits in Handling the Corona Virus Disease 2019 (COVID-19) Outbreak;
  - b. that in order to follow up on the Instruction of the Minister of Home Affairs Number 53 of 2022 concerning the Prevention and Control of Corona Virus Disease 2019 during the Transition Period Toward Endemic Status, it is necessary to stipulate a Regional Regulation on the Revocation of Bekasi City Regional Regulation Number 15 of 2020 concerning the Adaptation of New Habits in Handling the Corona Virus Disease 2019 (COVID-19) Outbreak;

- Bearing in mind
- : 1. Article 18 paragraph (6) of the 1945 Constitution of the Republic of Indonesia;

2. Law Number 9 of 1996 concerning the Establishment of the Municipality of Bekasi (State Gazette of the Republic of Indonesia of 1996 Number 111, Supplement to the State Gazette of the Republic of Indonesia Number 3663);
3. Law Number 23 of 2014 concerning Regional Government (State Gazette of the Republic of Indonesia of 2014 Number 244, Supplement to the State Gazette of the Republic of Indonesia Number 5587), as amended several times, most recently by Law Number 6 of 2023 concerning the Stipulation of Government Regulation in Lieu of Law Number 2 of 2022 on Job Creation into Law (State Gazette of the Republic of Indonesia of 2023 Number 41, Supplement to the State Gazette of the Republic of Indonesia Number 6856);
4. Law Number 30 of 2014 concerning Government Administration (State Gazette of the Republic of Indonesia of 2014 Number 292, Supplement to the State Gazette of the Republic of Indonesia Number 5601), as amended several times, most recently by Law Number 6 of 2023 concerning the Stipulation of Government Regulation in Lieu of Law Number 2 of 2022 on Job Creation into Law (State Gazette of the Republic of Indonesia of 2023 Number 41, Supplement to the State Gazette of the Republic of Indonesia Number 6856);

With the Joint Approval of

THE MAYOR OF BEKASI  
DECIDE:

To stipulate : A REGIONAL REGULATION ON THE REVOCATION OF REGIONAL REGULATION NUMBER 15 OF 2020 CONCERNING THE ADAPTATION OF NEW HABITS IN HANDLING THE CORONA VIRUS DISEASE (COVID-19) OUTBREAK.

## Article 1

At the time this Regional Regulation comes into force:

- a. Bekasi City Regional Regulation Number 15 of 2020 concerning the Adaptation of New Habits in Handling the Corona Virus Disease 2019 (COVID-19) Outbreak (Bekasi City Regional Gazette of 2020 Number 15); and
  - b. Bekasi City Regional Regulation Number 9 of 2022 concerning Amendments to Bekasi City Regional Regulation Number 15 of 2020 concerning the Adaptation of New Habits in Handling the Corona Virus Disease 2019 (COVID-19) Outbreak (Bekasi City Regional Gazette of 2022 Number 9),
- are revoked and declared no longer valid.

## Article 2

This Regional Regulation shall come into force on the date of its promulgation.

In order that everyone may be informed, this Regional Regulation shall be promulgated by placing it in the Regional Gazette of Bekasi City.
